

# Association Membership Application and Agreement Form

I wish to apply for Association Membership with the Swan Christian Education Association Inc. I understand that I need to sign the agreement. I will also provide referees who can support my Christian faith and lifestyle declaration and if requested, attend an interview with the Association Membership Committee.

## Preamble

In considering applications, the Committee must ensure that all members meet the requirements of membership. This is particularly important as members have the opportunity to set the direction and tone for the Association. Association Membership is available to persons whose vision for and commitment to Christian Education is greater than the immediate needs of their own children and the school they attend.

## Agreement

- I understand that an Association Member must have a clear testimony of faith in the Lord Jesus Christ and live in a manner compatible with a Christian lifestyle, including regular fellowship in a local church, and I attest to both requirements in my life.
- I wholeheartedly support the Association's Statement of Faith, Controversial Issues Clause, Foundational Beliefs and Educational Goals.
- I accept that if my circumstances change, I may resign my membership by advising the CEO/Board.
- I undertake to support SCEA through attendance at Association meetings.
- I will undertake to regularly uphold the Association in prayer.
- I accept the responsibility to prayerfully nominate fellow members to the SCEA Board.
- I understand that as an Association Member I may serve on the SCEA Board, if elected (and I am not a member of the SCEA staff).
- I accept that my membership may be terminated by the SCEA Board.
- I agree to follow the Association's dispute procedures and abide by the outcome.
- I agree to pay an annual membership fee (note: fee is waived if you are paying SCEA school fees).
- I understand that as a member, my name and nominated contact address will be listed on the Association's member register. Under the Associations Incorporation Act 2015 other Association Members may access or request copies of this register. Other personal details, such as my phone number and addresses other than my nominated contact address will be stored separately and not made available to other members but may be used by SCEA to communicate with you.
